LAW ENFORCEMENT MOTORCYCLE TRAINING SEMINAR

RELEASE OF LIABILITY

The Honorable Larry Campbell, Sheriff of Leon County, Tallahassee, Florida on behalf of that law enforcement agency commonly known as the Leon County Sheriff's Office, has agreed to host the 8<sup>th</sup> Annual Capital City Challenge Law Enforcement Motorcycle Training Seminar (EVENT). The EVENT will be held at Doak Campbell Stadium, parking lot B and all benefits realized from the EVENT will be donated to the Leon County Special Olympics and Kidz 1<sup>st</sup> Fund. Funding will be obtained through sponsorships. The EVENT is open to all members of the public safety profession who are now or were previously assigned to a law enforcement motorcycle unit. In consideration for the privilege and benefits to be derived from participating in the EVENT, Sheriff Campbell (Sheriff) is requiring all participants to execute this waiver, release and indemnification.

Participation in the EVENT will include a law enforcement motorcycle skills competition which is intended to promote safe motorcycle riding skills. The participant will be expected to ride/operate a motorcycle through the competition course and the competition course may consist of, but not be limited to, five obstacles that are designed to mimic daily riding scenarios for a motor officer. There will be an un-timed heat and a timed heat with the winner being declared at the end of the competition. The participant fully understands and appreciates the risks associated with operating a motorcycle in such a competition. The participant having actual knowledge of the EVENT activities expressly assumes these and all risks arising in any way out of the participant's participation in the EVENT. The participant represents and warrants that he/she fully understands any and all risks associated with the EVENT and further understands that he/she is solely responsible for his/her own health and safety. The participant understands that at all times relative to the EVENT, the privilege of his/her participation shall be governed by the Sheriff (inclusive of officers, officials, representatives and employees) and that the participant will abide by any directions given by such personnel of the Sheriff.

On behalf of the participant and participant's heirs, executors and assigns, and in consideration of his/her entry being accepted in the EVENT, the participant does hereby waive and personally assume any and all risks and liability for damages, losses, personal injuries or death which the participant might suffer, sustain or cause while participating in the EVENT and the participant does hereby release and forever discharge the Florida State University, Florida State University Board of Trustees, Florida State University Police Department, Tallahassee Police Department, Leon County Sheriff's Office, and their officers, agents, employee representatives, and other personnel (in their official and individual capacities), the County of Leon County, Florida any and all sponsors, Florida Public Safety Institute, Leon County Special Olympics, Florida Special Olympics and the Kidz 1<sup>st</sup> Fund (collectively, the 'Releasee') from any and all claims, demands, actions, damages, or suits at law or equity of whatever nature which the participant has or may hereafter acquire against the Releasee as a result of the participant's voluntary participation in the afore described activities, and the participant hereby holds harmless and agrees to indemnify Releasee for all damages, attorney's fees and cost which may be incurred in defending any such demands, claims, actions and the like.

The participant agrees, understands, and represents that his/her physical condition is the participant's sole responsibility and participant has full knowledge of the risks involved in riding/operating a motorcycle and that he/she is physically fit and has sufficiently trained in order to participate in such an event.
